A MESSAGE FROM THE BOARD PRESIDENT JOHN BEEKER

First, I want to acknowledge the work of our staff who went to extraordinary lengths to assist the Moreland courts Community during the record setting snowfall on Martin Luther King Day. Understaffed because of the snowstorm, only a few employees were able to get to Moreland Courts that day. The few staff who were able to get here, arrived early and stayed late to help with the Herculean snow removal effort. The efforts of Larry McHugh, Glenn Henry, Mildred Brooks and Paul Stroud were above and beyond the call of duty.

The Board began has begun the year with a lot on its plate. On the recommendation of the Facilities Committee we approved funding and a contractor to undertake the Gas Meter Consolidation project. This will consolidate gas meters of individual units into a master meter, thus eliminating user fees paid to the gas utility by unit owners that typically amount to more than \$30/month. Board members and senior staff are working with our organizational development consultant to formulate a new strategy for staff oversight and for enhanced communications. A new committee of residents has been launched to contribute to and oversee the preparation of a monthly newsletter. We are making arrangements to assure that our annual meeting with residents will be conducted this year after a lapse of two years because of the pandemic. Plans are afoot for activities to celebrate the Moreland Courts Centennial year. Mebby Brown has been appointed to coordinate this effort with the General Manager. And the Board is finalizing a mission statement to guide its operations after hearing comments from a number of residents on the draft. Thanks are due to all who made the effort to offer comments on this."

current rules in force at Moreland Courts pertaining to pet ownership:



Back in the day, pet owners at Moreland Courts were required to hold their pets in their arms on elevators. The first MCCA Rule Book had a stern warning for pet owners: "The opportunity to keep a pet in a Unit should be considered a privilege and not a right, and those who abuse the privilege shall lose it". Today we take a softer tone. The current Moreland Courts Rule Book "welcomes responsible pet owners and their pets".

- 1. I can keep my pet cobra in my Unit so long as it never escapes.
- 2. My right to privacy precludes the need to register my pet with Management.
- 3. Unit owners are allowed one dog, a dog and a cat or two cats per Unit.
- 4. Only the police have the authority to determine whether my pet poses a danger to others.
- 5. The grassy spots in the back line area are an excellent location for my dog to relieve himself.
- 6. Receptacles for pet droppings are located on the Condominium Property at four different locations and on adjacent public streets.
- 7. Failure of dog walkers to pick up after their dogs is a violation of Cleveland and Shaker Heights public ordinances.
- 8. Once inside the common areas of Moreland Courts, my dog can be unleased.
- 9. Cat litter must be securely tied in an air-tight plastic bag and deposited in the rear halls for pick-up and disposal.
- 10. Owner supplied dog treats are given out to dogs when they stop by the Security Office.
- 1. False:Pets are limited to domestic household pets, such as dogs, cats, birds and fish.2.False. All pets must be registered with the Management Office by filling out a Pet Responsibility Registration Form. 3. True.4.
